Limited Warranty

The Genuine distributor warrants all parts of the vehicle except those listed under the caption "What is not covered."
(See reverse side). This warranty covers any repairs needed to correct defects in materials or workmanship.

Some states do not allow the exclusion or limitation of incidental or consequential damages,
so the above limitation or exclusion may not apply to you.

WHAT MUST YOU DO?

You must properly use, maintain and care for the vehicle as outlined in the Genuine owner's manual.
You must maintain a record of the vehicle's required periodic service and inspection.
Periodic service and inspection are considered regular maintenance and are not reimbursable.

WHAT MUST ANY AUTHORIZED GENUINE DEALER DO?

Warranty repairs will be made at no charge for parts or labor. Any new parts replacement will be made with new parts.

Other warranty terms and rights under various state's laws.

Any implied warranty of merchantability and fitness for a particular purpose shall be limited to the duration
of this written warranty. (See reverse side for details). Some states do not allow limitations on how long an implied
warranty lasts, so the above limitations may not apply to you. This warranty gives you specific legal rights.

You may have other rights, which may vary, from state to state.

Genuine's distributor does not authorize any person to create for it any other
warranty, obligation, or liability in connection with this product.



HOW LONG IS THE WARRANTY?

The warranty is effective for TWO years from the date of purchase by the original owner.

WHAT IS NOT COVERED? (WARRANTY EXCLUSIONS)

- Batteries (the battery that comes with the scooter is covered for ONE month);
- Any damage resulting from negligence of the periodic maintenance;
- Any damage that results from repair, adjustment or maintenance operations by any methods other than those specified by Genuine;
- Any damage that results from hard driving due to a race, rally, or operation in a location not generally used for driving;
- Any damage which results from use beyond the limitations specified in the Genuine Operation Manual such as overloading the vehicle, or any damage from use under abnormal conditions;
- Any damage caused when the product is used as a rental vehicle;
- Any damage that results from the use of non-genuine parts or accessories or fuel, lubricant or fluid not specified by Genuine;
- Any damage that results from modifications of the product;
- Any damage that results from the passage of time (natural fading of painted surfaces, plated surfaces, sheet peeling and other deterioration);
- Any damage that results from operations not in accordance with those specified in the Operation Manual;
- Sensational phenomena that do not affect performance or function of the product such as engine noise, vibration, or seepages;
- Consumable replacement parts. Genuine will not warrant parts worn due to natural wear and tear such as spark plugs, drive chains, air cleaners, brake shoes, clutch disks, light bulbs, fuses, rubber parts, tubes & tires, oils and cables;
- Any damage due to improper storage or transport;
- Any damage which results from repair, adjustment or maintenance operations performed by any person other than Genuine's distributor or the Dealer;
- Any damage which results from unavoidable natural disasters, fire, collision, theft, and second damages based on any of these occurrences;
- Any damage which results from oils and smoke, chemical products, bird droppings, sea water, sea-breeze, salt or other similar items;
- Incidental or additional expenses incurred for making any claims such as those for towing, communications, hotels and meals, as well as any losses during maintenance period, such as loss of time, loss of business and rental car expenses.
